# 4. Approve a Resolution listing the MPO's priority projects to submit to TxDOT for inclusion into the 2025 Unified Transportation Program

Staff has been notified of the recent release of available funding projections related to the 2025 TxDOT Unified Transportation Program (UTP). The MPO will benefit from additional funding over the ten-year timeframe 2025-2034 with the additional amount of \$35M. It is important that a decision concerning how to utilize these projected funds is made as soon as possible to ensure that funds are not left unprogrammed. This is the reason for staff requesting a special meeting of the Policy Board. A decision on how to program the funding is expected to be delivered to TxDOT by February 16<sup>th</sup>.

At the Special Policy Board meeting held on February 16<sup>th</sup> 2024, the Policy Board decided to program additional funding based on priority as seen below:

The projects listed below are in priority order.

Funding indicated is from Category 2.

- Add funding to US 385 at South Loop 338 to account for updated cost estimate -\$7M
- 2. Add the widening of SH 158 from Wadley to Briarwood -\$6.5M
- 3. Construct a new interchange at Loop 338E at 87th Street \$35M
- 4. Construct a new interchange at BI-20 at Faudree \$5.5M (partially funded)
- 5. Intersection improvements & ramp reconfiguration from Midland Dr. to W. of Midkiff \$5M
- 6. Construct a new interchange on SH 191 at CR 1250 \$16M (partially funded)

Total: \$75,000,000

A motion to approve a Resolution listing the MPO's priority projects to submit to TxDOT for inclusion into the 2025 Unified Transportation Program was made by Mike Gardner, seconded by Steve Thompson, and approved unanimously
