

RESOLUTION NO. 2023-06-19-1

A RESOLUTION ADOPTING THE PAVEMENT AND BRIDGE CONDITION PERFORMANCE TARGETS ESTABLISHED BY THE TEXAS DEPARTMENT OF TRANSPORTATION

WHEREAS, the 2021 Infrastructure Investment and Jobs Act and previous transportation bills require the implementation of Performance Measures to assist in the transportation planning process; and

WHEREAS, Texas Department of Transportation has established targets for four pavement conditions and two bridge conditions Performance Measures:

Pavement Conditions:

- 1. Percentage of Interstate pavements in Good condition,
- 2. Percentage of Interstate pavements in Poor condition,
- 3. Percentage of non-Interstate NHS pavements in Good condition,
- 4. Percentage of non-Interstate NHS pavements in Poor condition,

Bridge Conditions:

- 1. Percentage of NHS bridges classified in Good condition, and
- 2. Percentage of NHS bridges classified in Poor condition,

WHEREAS, the Texas Department of Transportation has officially established pavement and bridge condition targets dated February 10, 2023, attached hereto, and incorporated herein; and

WHEREAS, the Permian Basin MPO is also hereby renewing its commitment to all member agencies to readily and consistently identify problem locations associated with road and bridge condition.

NOW, THEREFORE, BE IT RESOLVED, BY THE PERMIAN BASIN METROPOLITAN ORGANIZATION THAT:

The Policy Board hereby adopts the 2023 Texas Department of Transportation Pavement and Bridge Condition Performance Targets within the Metropolitan Area Boundary, attached hereto, and incorporated herein, on this the 19st day of June 2023.

BE IT FURTHER RESOLVED that the Policy Board will plan and program projects that contribute to the accomplishment of said targets.
